Dear Representative Meadows:

The Michigan Coalition for Children and Families (MCCF) fully supports legislative action during this 95th legislative session that establishes a definition and creates guidelines for evaluating juvenile competency to proceed in delinquency hearings. MCCF is a statewide, non-partisan network of child-focused organizations and individuals with a shared mission of improving the quality of life for Michigan children and families. Since 1983 MCCF has advocated on behalf of the health, education, safety, and security of children.

The juvenile justice system was founded on the principles of rehabilitation, providing guidance for wayward youth and stepping in as a surrogate parent when needed. As the system matured, it became clear that core protections were required in order to navigate the fine line between service provision and punishment.

Advances in adolescent development research have reinforced the need for protections for kids facing charges. The MacArthur Foundation's Research Network on Adolescent Development and Juvenile Justice documented significant differences in the way that younger children process information about court proceedings. According to the most robust study on juvenile competency to date, 30 percent of 11-13 year olds and nearly 20 percent of 14- and 15-years olds are found incompetent to proceed in delinquency hearings. Emerging research indicates a necessity to consider a child's lesser capacities owing to biological, emotional, and psychological immaturity.

Michigan's county-based juvenile justice systems need guidelines about determining juvenile competency so that standards are applied consistently across county lines.

MCCF encourages the Legislature to use research as a guide for enacting legislation that:

- 1.) Establishes a definition for juvenile competency that recognizes that kids are different than adults;
- 2.) Acknowledges that very young children should be presumed incompetent and should not be prosecuted;
- 3.) Requires that the qualified examiner has the expertise and experience of working with children and adolescents in a court setting;
- 4.) Outlines the content of the examination such that a child's ability to comprehend court procedures is based on developmentally-appropriate criteria.

Legislation to address juvenile competency to proceed in delinquency hearings will provide courts the guidance to effectively protect kids. MCCF is happy to serve as a resource as the legislation is developed.
